CRIMINAL PROCEDURE AND CORRECTIONS

CONDUCT OF TRIAL

918.13 Tampering with or fabricating physical evidence.—

(1) No person, knowing that a criminal trial or proceeding or an investigation by a duly constituted prosecuting authority, law enforcement agency, grand jury or legislative committee of this state is pending or is about to be instituted, shall:

(a) Alter, destroy, conceal, or remove any record, document, or thing with the purpose to impair its verity or availability in such proceeding or investigation; or

(b) Make, present, or use any record, document, or thing, knowing it to be false.

(2) Any person who violates any provision of this section shall be guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

of evidence tampering arising out of his deletion from his work cellular phone of a video he recorded of a witness making statements about a case in which two **officers** who were friends of detective were the defendants; evidence did not show that defendant deleted the video from his phone with the purpose of impairing its availability for the investigation, as defendant had already shown the video to his supervisor, texted it to one of the **officers**, and e-mailed it to an attorney for the **police** benevolent association, and video was eventually recovered from two of those locations. West's F.S.A. § **918.13**.

Synopsis

Background: Defendant was convicted in the Seventeenth Judicial Circuit Court, Broward County, Michael A. Robinson, J., of evidence tampering. Defendant appealed.

[Holding:] The District Court of Appeal, Gross, J., held that defendant could not be convicted for deleting from his work cellular phone a video he had already shown, texted, and e-mailed to others.

Reversed and remanded.

the items so that they could not have been retrieved, it would be another matter, like swallowing. In this case, however, where he merely dropped the cocaine rocks and tossed the container on the ground, and both were easily found, the evidence was insufficient. Otherwise a tampering conviction could be obtained whenever a suspect merely drops drugs on the ground.

Id. at 39.

Similarly, in *Evans v. State*, 997 So.2d 1281 (Fla. 4th DCA 2009), we held that the trial court erred in denying a motion for judgment of acquittal on a charge of tampering with **evidence** where the defendant threw a crack cocaine rock onto sandy ground as **officers** approached for a stop. We held that the fact the **officers** were unable to find the drugs due to the nature of the surface of the ground did not demonstrate the necessary specific intent to tamper with or **conceal the evidence**. *Id.* at 1284.

Such equivocal conduct differs from that conduct that completely destroys potential evidence, such as swallowing an object. See *State v. Jennings*, 666 So.2d 131, 133 (Fla.1995); *McKenzie v. State*, 632 So.2d 276, 277 (Fla. 4th DCA 1994) (holding that “swallowing a substance” demonstrates the necessary intent to amount

to a violation of section **918.13**, just like “flushing it down a toilet”).

[5] In this case, after appellant recorded the video on his cell phone, he showed it to his supervisor, texted it to Koepke, and e-mailed it to an attorney for the **Police Benevolent Association**. As we know from videos that have gone viral, texting or e-mailing a video is the antithesis of trying to destroy it. In fact, with the assistance of technology, the video was recovered from two separate locations. There was insufficient evidence of appellant's intent to violate the tampering statute. In addition, there was insufficient evidence that the video was “destroy[ed]” within the meaning of the statute; the statute does not criminalize deleting evidence existing in the memory of a particular electronic device, particularly where such evidence resides elsewhere in the electronic ether. The trial court's denial of appellant's motion for judgment of acquittal was therefore erroneous.

We reverse the conviction and remand to the circuit court with direction to grant the motion for judgment of acquittal.

Occasionally, a person faces a situation that requires doing something illegal in order to prevent serious harm. In such a situation, the defense of necessity, which is also called the "lesser of two evils" defense, may come into play. (For more on this area of law, see What's the difference between duress and necessity? (https://www.nolo.com/legal-encyclopedia/whats-the-difference-between-duress-necessity.html))

A defendant who raises the necessity defense admits to committing what would normally be a criminal act, but claims the circumstances justified it.

Normally, to establish a necessity defense—a tall order—a defendant must prove that:

- there was a specific threat of significant, imminent danger
- there was an immediate necessity to act
- there was no practical alternative to the act
- the defendant didn't cause or contribute to the threat
- he or she acted out of necessity at all times, and

- the harm caused wasn't greater than the harm prevented.

Traditionally, the necessity defense isn't available to a defendant who kills an innocent person, regardless of the circumstances.

Example: A defendant was convicted of driving with a suspended license for travelling to a telephone to call for help for his pregnant wife. He didn't have his own phone, and his wife was experiencing back and stomach pains. He first walked to his only neighbor's house to use the phone, but found no one home. He then drove a mile and a half to the nearest phone to call his mother-in-law for help. On the drive back home, the police stopped him for a broken tail light and arrested him for driving with a suspended license. Recognizing that circumstances beyond one's control sometimes force a defendant to engage in illegal conduct, the appellate court ruled that the trial court should have allowed the defendant to present a necessity defense. (*State v. Cole*, 403 S.E.2d 117 (S.C. 1991).)

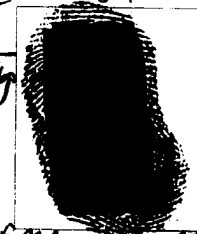

Question: I'm studying for my driving exam and I'm confused about the difference between stopping distance and braking distance.

Answer: It can be a little confusing, I'll try to sort it out for you.

If you encounter an emergency on the road requiring you to stop suddenly, there are two parts that make up the total stopping distance.

- Reaction distance
- Braking distance

When you're in an emergency situation, it takes time to react to the emergency, to brake, and to finally bring your vehicle to a complete stop. Remember that your vehicle is traveling a surprisingly long distance every second. At 40 mph, your vehicle will travel approximately 60 feet per second and a lot can happen in that short amount of time.

Reaction time

The time it takes you to react and respond to an emergency can be broken down into three parts:

- Perception or awareness time
- Decision time
- Action time

Let's look at each part by imagining a scenario that requires you to make a sudden stop. Let's say that you are traveling at 40 mph when the driver of the car ahead of you suddenly applies his brakes.

Perception time

The perception or awareness time is how long it takes before you are even aware that the driver ahead is suddenly stopping. If you aren't expecting an emergency, it will take time before you realize that the car ahead is suddenly braking

Decision time

Now that you're aware of the emergency ahead, you have to decide what to do. Will you hit the brakes or swerve into another lane to go around? If you try to change lanes, is the lane clear or are there other vehicles that may be in the way? It takes time to decide what to do. In our emergency, let's say that you decide to hit the brakes but that decision took time

Action time

Now that you've decided you're going to brake, you have to move your foot from the gas pedal to the brake pedal and push it all the way down. That also ate up precious time.

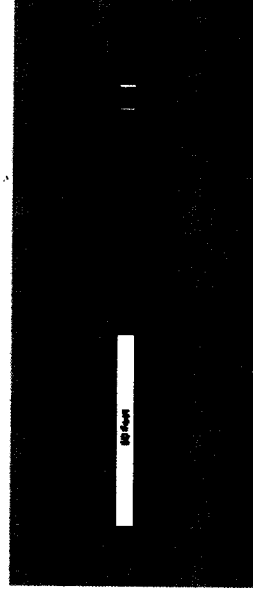
For the average person, the total reaction time can take from three-quarters to a full second. At 40 mph, if your reaction time is one full second, you'll have traveled almost 60 feet before applying the brakes.

Braking Distance

Now that you've applied the brakes, it still takes time to come to a complete stop. For an average car that weighs almost 3,000 pounds, that can take up to 60 feet.

Total stopping distance

So, the total stopping distance is made up of both the reaction distance plus the braking distance. Adding the two together means that, at 40 mph, it can take up to 120 feet before your vehicle will come to a complete stop. That's why maintaining a safe following distance between you and the vehicle ahead is so important.

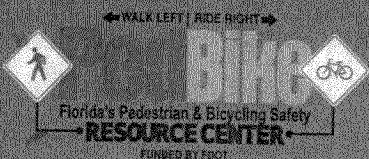

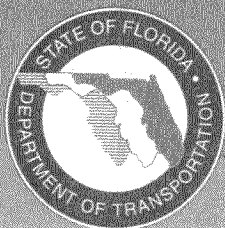

Dealing With Rude Drivers

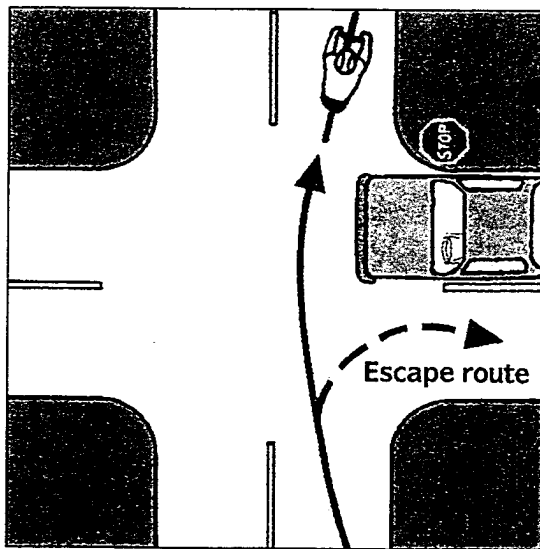
Some drivers try to cut across in front of you. They inch out from a driveway or stop sign and treat you as if you have no right to the road.

Be defensive but stand up for your rights. Don't let rude drivers spoil your trip. Here's how to assert your right of way.

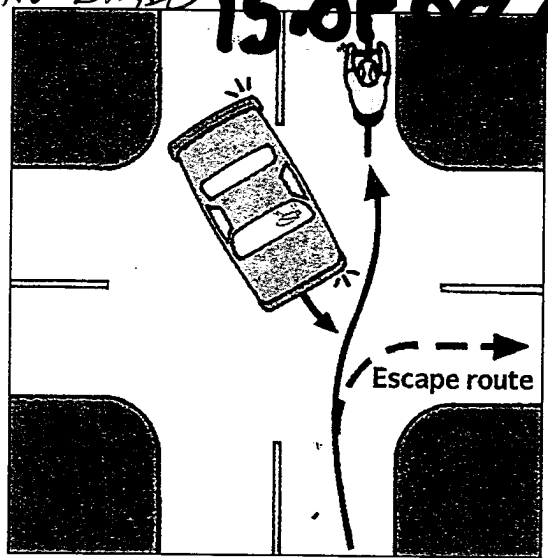
With a little experience, and after learning the emergency braking techniques in this booklet, you'll have a good idea of your bike's stopping distance in any situation.

With that in mind, assert your right of way by continuing to move forward – and keep pedaling, since your turning pedals are a clear signal to the driver. Meanwhile, figure out when you'll have to hit the brakes or turn, in case the driver pulls out in front of you anyway.

In most cases the driver will stop and wait for you before you have to brake. Move on past the car. In the odd case that the driver doesn't stop, you'll be prepared to brake or turn in time.



To assert your right of way when a driver inches out from a stop sign, check behind you for traffic, then keep pedaling as you move farther into your lane.



To assert your right of way when a driver threatens to turn left from ahead of you, move into your lane to make yourself more visible, then right to prepare your escape if necessary.

The real danger at intersections is from drivers who run stop signs or red lights without even slowing down, or who stop and then start again without looking. While these drivers are rare, always ride defensively, especially at intersections.

Reporting Bad Drivers

If a motorist inadvertently or maliciously causes you to feel threatened or attempts to harm you, make note of the license plate number and, if possible, a description of the driver. In some places you can report the incident to the Department of Motor Vehicles. If the offender is a commercial driver, inform the driver's employer. You may be able to report the driver's employer to the Department of Motor Vehicles or the licensing agencies that regulate trucking. You may also be able to press criminal charges for assault if you believe the driver attempted to hit you or threw something at you, or assault and

battery if you were struck by the car or some other object.

NOT ATTEMPTED MURDER

In the Event of a Crash

After any fall or crash, seek appropriate medical attention, and before your next ride, have a qualified mechanic check that your bicycle is in safe working order.

Most bicycle crashes don't involve other people, and can be prevented by good bicycle handling techniques. These crashes typically result from the bicyclist's losing control on a bad surface or hitting a fixed object (see Moritz, William, *Adult Bicyclists in the United States — Characteristics and Riding Experience*, Transportation Research Board, 1998). But if you are in a crash involving another person, first get appropriate medical attention for all parties. Gather as much information at the scene as possible including the other parties' names, addresses and insurance information. Keep in mind that you may not discover an injury, or damage to your bike, until later. Seek the advice of an attorney, especially if there is any dispute as to who was at fault. Be wary — many people including police officers and insurance officials do not understand bicyclists' rights to the road and this may cause them to have a bias against you. For this reason, do not apologize or say anything that could be interpreted as an admission of fault and do not say that you are not hurt — you may not realize that you are injured until later. If the investigating officer takes a driver's version of what happened and it differs from yours, politely insist that the police officer also record your version.

Reducing Friction Between Bicyclists and Motorists

The main way bicyclists annoy motorists is by performing unpredictable maneuvers this booklet warns against.

Fearful instruction — “always keep away from traffic” — is passed down to children by parents who don't know much about bicycling — the blind leading the blind. From about 1930 to 1965, few adults rode bicycles in North America, and that was long enough for incorrect ideas about bicycling to become deeply rooted.

Certainly, children shouldn't be allowed to ride bicycles in heavy traffic, any more than they should be allowed to drive cars. But that doesn't mean that adult bicyclists should have to ride like children.

There will always be people in cars who yell, “Get off the road.” Don't let them bother you. Position yourself to encourage drivers to maneuver around you correctly. If most bicyclists in your community use incorrect maneuvers, drivers will have some trouble understanding your correct maneuvers. You need to make especially clear signals. With experience, drivers will discover that they have an easier time with bicyclists who use correct maneuvers.

The number of adult bicyclists is increasing, and in the long run, more drivers will come to understand that it makes sense to share the road. Bicycles use less road space than cars; every person who chooses to ride a bicycle rather than drive is reducing traffic problems.

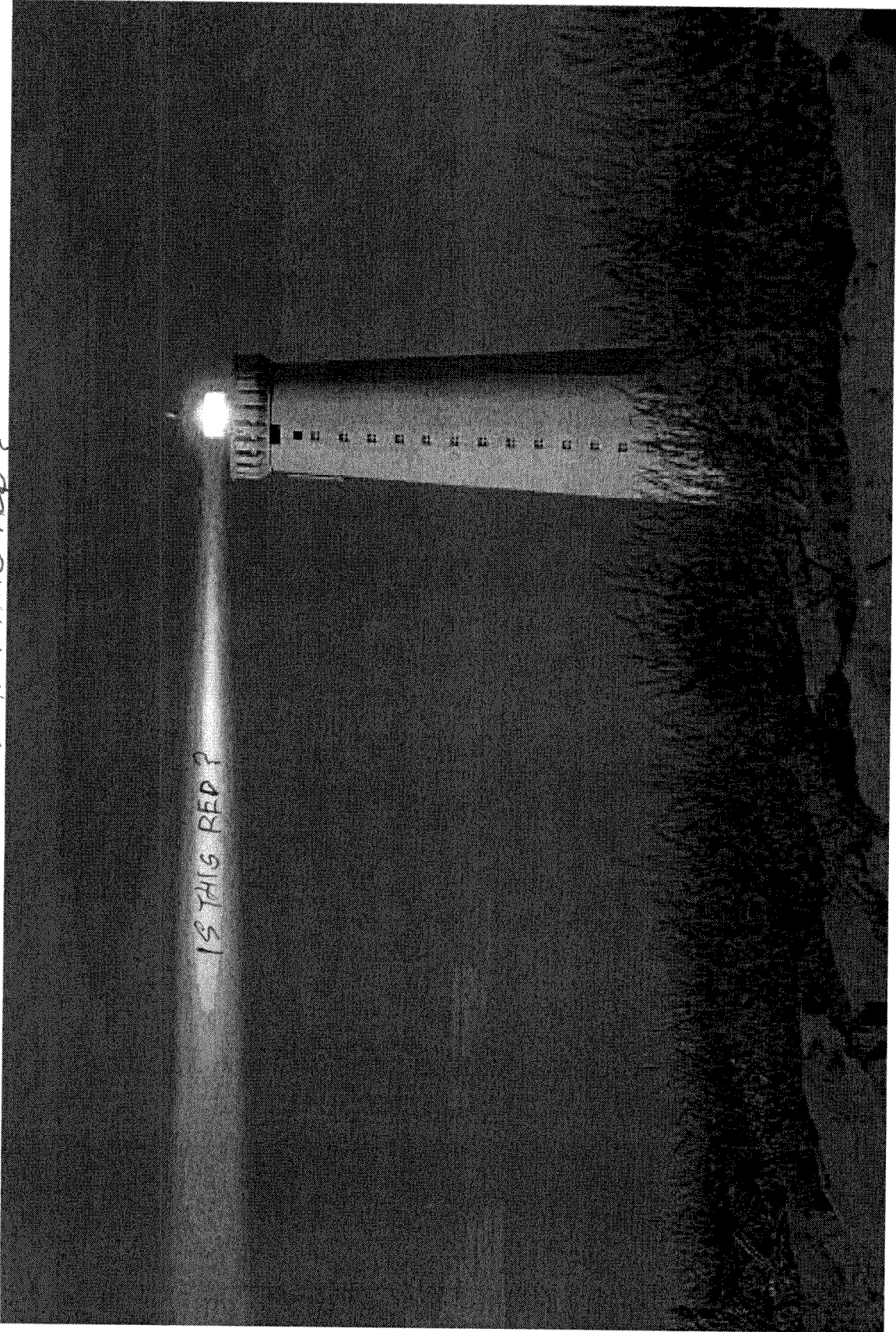

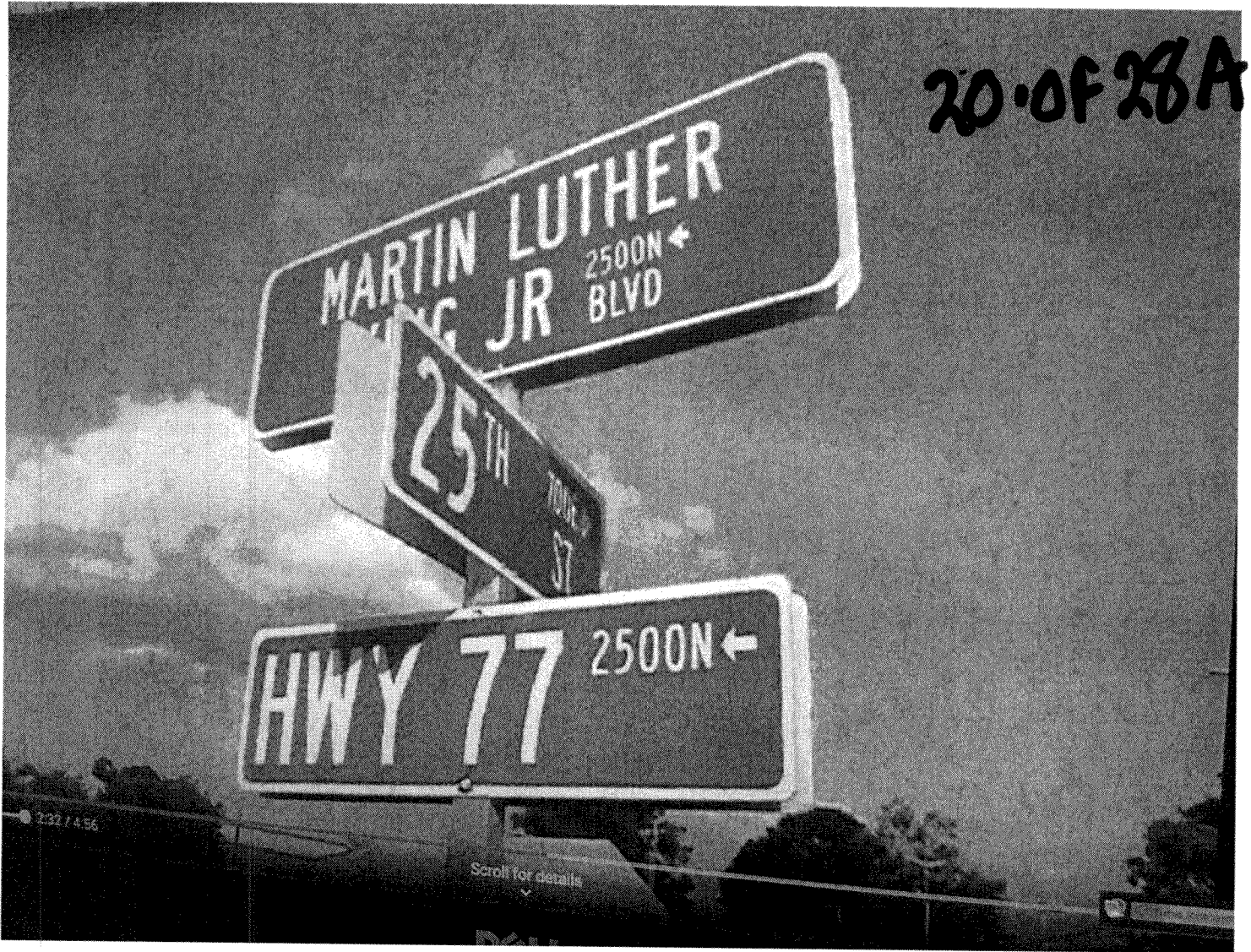

Roof Strobes Draw Crucial Attention

Being large and yellow, school buses are inherently some of the most noticeable vehicles on the road. But in certain conditions, such as inclement weather and low light, some added conspicuousness can help other motorists see the bus in time to stop safely, preventing collisions and illegal passbys.

The myriad lights required on school buses are key deterrents for these incidents. But one type of light not always found on school buses is the roof-mounted strobe.

These strobes are positioned on the longitudinal centerline of the roof, usually close to the rear but sometimes in the front. Their lenses are typically clear or amber, and the lights have an output of around 10 joules. Their intense flashing action can be another effective element in bolstering safety.

Attracting attention

Some operations, such as Henry County School System in McDonough, Ga., have roof-mounted strobes turned on whenever the bus is in transit. Beverly Skipper, director of transportation at Henry County, says that the frequency of accidents in which school buses are rear-ended by other vehicles has dropped significantly since the state included the strobes in its bus specifications.

"We still get those types of accidents, but they're not as common as they used to be," Skipper says.

The district has found the strobes to be particularly effective in foggy and smoky conditions. Skipper says that the relatively low cost of the units – about \$100 per bus in Henry County's experience – is well worth the added safety they provide.

Skipper recommends that any school bus operation not already using the strobes look into them. "It is worth installing them, because they do save lives," she says.

Iowa Park (Texas) Consolidated Independent School District requires its bus drivers to run their strobes at all times. The policy was adopted at the request of the local police department.

Kent Chapman, who handles fleet maintenance and dispatching at the district, says the strobes' benefit is clear. "It's an attention-getter – it makes [motorists] aware that there's a vehicle ahead that is probably traveling slowly," he says.

Donna Sullivan, assistant director of transportation at Manhattan-Ogden (Kan.) Public Schools, says that her operation quickly saw the benefit of roof strobes after equipping their fleet a few years ago. "We always keep track of stop-arm violations, and there was a significant drop after we put strobe lights on the buses," Sullivan says.

State by state

Regulations on roof-mounted strobes vary by state. In a survey of state directors of pupil transportation,



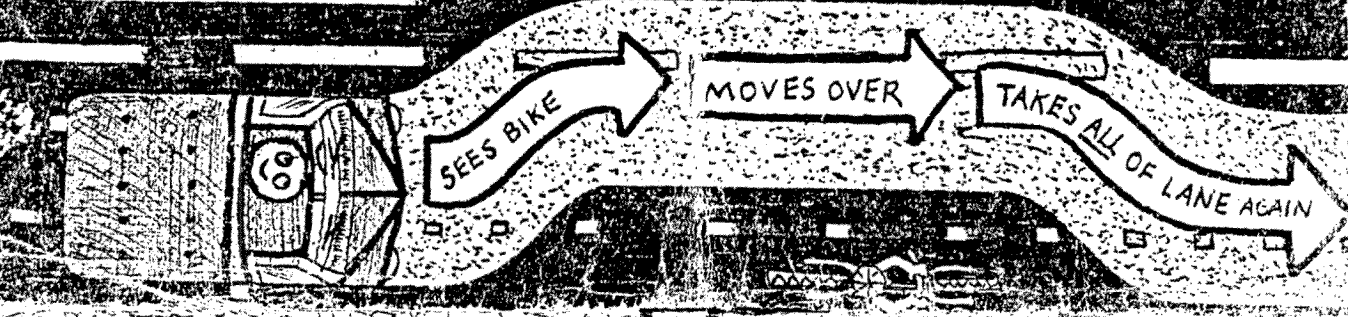
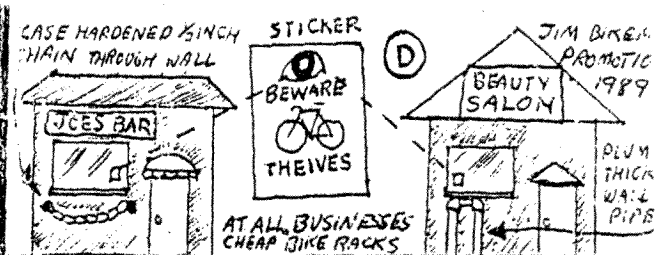
