Our View

Democracy comes with fleas

GET USED TO IT: They keep the big dogs scratching.

If St. Francis of Assisi had known ~~_____~~ "Bikeman" ~~_____~~, the world today might well be deprived of the 12th century ascetic's prayerful prescription for selfless peace and love. ~~_____~~'s own attorney, a public defender, calls him "a nuisance, a pain in the butt."

Waylon Graham, an attorney with considerably more legal weight, sees the larger context. "Unfortunately for public servants, our *Constitution* and our system of government allows people to be gadflies and annoyances - in short, to pester the heck out of ya," he told *The News Herald's* David Angier. "That's the price that we pay to live in a democracy."

In Bay County, an increasing number of public officials seem unwilling to pay the price.

Last year the Lynn Haven city manager had a citizen arrested for "stalking" because he made public-records inquiries into the city manager's own background; the case was, of course, eventually thrown out. Last week a neophyte county commissioner wrote a public letter belittling critics of government as uneducated ignoramuses for whose opinion he cares not a whit; this is a career to watch, for sure.

~~_____~~ was in court this past week because the state attorney, Jim Appleman, had him arrested and jailed for tape-recording a conversation the two had in the State Attorney's Office building foyer. After the judge threw out the charges on Thursday, Appleman conceded the arrest had little, if anything, to do with enforcing law. He said ~~_____~~ had been a nuisance to his office. Still, he had no regrets.

"Hopefully, we won't have any more problems," Appleman told Angier.

Justice in such cases can come slowly - ~~_____~~ was arrested in February 2000 - and few people targeted by public officials for being too nosy come out of the ordeal eager to do it again. Most go quietly to their place on the outer rim of democracy. Unfortunately for Appleman - and especially for his receptionist on the front line ~~_____~~ probably will not.
