<p>The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: The named defendant did knowingly and intentionally make numerous phone calls to The Panama City Police Department over a period of two months. He did so with the sole purpose to harass the dispatchers. During some of these phone calls the defendant used profanity towards dispatchers. In most of the calls, he attempted to make reports of "super loud boom boom cars" but refused to give dispatchers necessary information to investigate the report. In some of the cases, even after attempting to take the report, he would call back and report it a second time. The defendant was warned several times not to call unless he had a legitimate business purpose but he refused and continued to call. Several of these recorded calls were documented in PCPD case numbers 14-15679, 14-17566, 14-17705, 14-17824, 14-17893, 14-18022 and 14-18200. The defendant has personal issues with Law Enforcement, specifically The Panama City Police Department, The Bay County Sheriff's Office and The Florida Department of Law Enforcement and it is believed to be the reason for the harassment.
