The defendant in this matter was riding his bicycle in the roadway on a busy stretch of

to ride his bicycle in the roadway per Fla. Stat. 316.2065. The statute indicates specifically
that the bicyclist should stay as close as practicable to the right hand curb of the roadway,
and while the deputy stated that the defendant was weaving into the middle of the most
right-hand lane and didn't stay as close as practicable to the curb, the State will be unable
to prove beyond a reasonable doubt that the defendant failed to comply with a lawful
command when he was asked to ride on the sidewalk in order to better the flow of traffic.
